These training sessions will be repeated, as necessary. <p>Currently we are educating students K-8 with Comprehensive Distance Learning Module as of August 31st and the Two-Hour Limited Instruction Model as of September 28th.</p> <p>Protocols in place with Jackson County Health Authority to notify of confirmed cases, provide contact logs, etc. and follow their instruction of how to proceed.</p> <ul style="list-style-type: none"> • Systematic disinfection of classrooms, offices, bathrooms and activity areas before and after each cohort daily. Disinfection will include end of day cleaning by a custodial team to all classrooms and common areas. Bathrooms and high frequency touch points will be cleaned by daytime custodial staff throughout the day. Activity areas (playground, outdoor areas) will be disinfected between each cohort group and at the end of the day by the school staff. • Students and staff with symptoms will not be permitted in the building.
